CMPD Regulators' dialogue: Global AI governance - The much-needed lifeline for startups?

As declining geopolitics affects technology policymaking globally, the risk for startups expanding beyond national borders is rising fast too. While national laws might be able to deal with simpler AI applications and LLMs, frontier models may require global rules - and an international body to oversee them. The ICAO (Aviation), CERN (Nuclear), IAEA (Atomic Energy), are organisations from the past that embody ways to govern a powerful new technology. And these have mostly worked.

But getting a global agency to oversee AI anytime soon might be quite the tall order.

So what can national policymakers do to create a framework that allows for startups at home to not only attract foreign capital, but expand beyond their borders easily, and at the same time contain risks from imported AI systems causing significant harm?

CMPD Investors' dialogue: AI has a real problem - The missing revenues!

It is estimated that about \$1 trillion will be spent on capex in the coming years, including significant investments in data centres, chips, other AI infra, and power grid. "Overbuilding things the world doesn't have use for, or is not ready for, typically ends badly," warned a Goldman Sachs report in June 2024.

Sequoia's David Cahn's rule of thumb is that companies in aggregate will need to generate about 4x in revenue (about \$600 billion) versus what they spend (\$150 billion) on Nvidia data centres. Currently, there isn't sight of such scale revenue.

Besides, most of this spend and commensurate revenue may accrue to big tech and the hyperscalers.

In this challenging environment, how can AI startups expect to capture, defend and grow market share? Which segment does most of the opportunity lie in - the application layer, vertical companies, foundation model providers, or something else altogether?

IOSCO Fintech Task Force Panel – The current state of play in regulating crypto-asset markets, AI and financial asset tokenization

Since its inception in 2022, the IOSCO FinTech Task Force's (FTF) priority was on addressing risks to investor protection and market integrity in crypto-asset and digital asset (CDA) markets, including Decentralised Finance (DeFi). Having finalised policy recommendations for CDA markets and DeFi in end-2023, the FTF has switched gears to support IOSCO members on the implementation of the policy recommendations, and shifted its policy attention to other major technological trends and developments in financial markets relating to Artificial Intelligence and Financial Asset Tokenization.

This panel will discuss how IOSCO is promoting implementation of the IOSCO CDA and DeFi policy recommendations, as well as provide insight into IOSCO's early thoughts on use cases, issues and challenges, as well as risks posed by artificial intelligence and financial asset tokenisation.

In the next phase of the project, BISIH will support a group of first mover countries (India, Malaysia, the Philippines, Singapore and Thailand) to implement Nexus in the real world to deliver benefits both individuals and businesses.
